It is to inform that, the Trust as per the Govt. orders has included the Maternal Care Obstetric Procedures under "Talli Suraksha" in Dr NTR Vaidya Seva Scheme and deployed online w.e.f 15.01.2019.

In this regard, guidelines were framed as per the recommendation of the Technical Experts and Trust Officials and herewith enclosed for information.

Hence, all the Network Hospitals empanelled for S4 category are requested to note the guidelines issued and to follow strictly for successful implementation of the "Talli Suraksha "

Talli Suraksha - Guidelines

The Trust as per the Govt. orders initiated the inclusion of the following Two Cashless Maternal Procedures under Dr.NTR Vaidya Seva and framed the following guidelines as per the inputs from all the Technical experts/Specialists for smooth and successful implementation of the “Thalli Suraksha”

New Obstetric Procedures

S.No	Type of Delivery	Package Price
1.	Normal Delivery	8,000/-
2.	Caesarean Section	14,050/-

- **Three Antenatal Check-ups** are Mandatory (to get 100% claim package)
- **Emergency Telephonic approval** in case of all Emergency cases and the contact numbers for emergency approval are as follows:

For Preauthorization.

1. **One of the Eligible Cards** along with Beneficiary Photo.
2. **Ante Natal Registration Card/Any other clinical document** with the following details:
 - Name of the pregnant women with Photo, Age, Height, Weight.
 - LMP, EDD, Gestation Age and details Anti-natal screening of Three Trimesters.
3. **First Trimester Investigations:**
 - Complete Hemogram, Urine routine Examination, VDRL, Viral Markers,
 - Blood grouping and Rh Typing, RBS, Thyroid Profile,
 - USG Abdomen (Gestational age, Placental location and Congenital anomalies)
 - If required any other investigations free of cost.
4. **Second Trimester Investigations**
 - Haemoglobin%, RBS, USG Abdomen, CUE
 - If required any other investigations free of cost.

5. **Third Trimester Investigations:**

- Haemoglobin %, RBS, USG Abdomen, CUE
- If required any other investigations free of cost.

Complaints & Clinical notes at the time of admission

Normal Delivery:

- Detailed notes and progress of labour shall be written as per the Prescribed Standard Treatment Protocol.
- Strict Aseptic precautions should be maintained in the labour room.
- Photograph of the mother with face on delivery table along with treating Doctor.
- Specific progress notes on augmented labour/ induced labour along with Partogram.
- Details of General Physical Examination (Treatment details of HTN, Diabetes Mellitus & Hypo /Hyper Thyroidism in needy pregnant woman)
- Details about Previous Deliveries
- Details about the Present Pregnancy
- Past History

Claims

- a. Clinical Specialist Notes on examination in latent phase, 1st stage, 2nd stage, 3rd stage and 4th stage of labour.
 - i. Progress of the labour
 - ii. 4th hourly examination of maternal vital data, abdominal & P/V examination and foetal monitoring in the latent phase & 1st stage of labour
 - iii. Half-an-hourly monitoring of maternal vital data, abdominal & P/V examination and foetal monitoring in the 2nd stage of labour as per requirement.
 - iv. Details of CTG in active phase of labour
- b. Labour Notes consists of Specialist Doctor's name, Assistant name of the Nurse and type of the anaesthesia if any used. Detailed note about Episiotomy/tears
- c. Photograph of Mother, New-born along with Umbilical Cord & Placenta and treating doctor immediately after the delivery.

- d. Uploading of Photos of Private parts without proper draping is objectionable.
- e. Delivery details including APGAR at -1-minute & at -5-minutes after the birth.
- f. Detailed notes about resuscitation of the baby by the Anaesthetist/ Paediatrician.
- g. Detailed note about amount of blood loss in Intra-Partum / Post-Partum period.
- h. Notes of examination of Mother for uterine contraction, bleeding p/v and vital data in Post-delivery clinical notes.
- i. General physical examination of the mother and child on second day after normal delivery.
- j. Acknowledgement of registration of Birth/ Birth Certificate.
- k. Discharge should be **after 48hrs of normal delivery** after thorough examination for Uterine contraction, Bleeding P/V and vital data of the Mother & discharge notes of the neonate by the Paediatrician with Post-Natal advice.
- l. Providing 10 days Post discharge Medicines as per the guidelines of the Scheme.

Guidelines for Caesarean Section

Apart from the above guidelines the following additional information is required for all Caesarean Sections.

1. Type of Surgery: - Elective or Emergency Caesarean section.
2. Detailed Indication, Clinical Notes, Partogram and Progress Notes for Surgery.
3. Pre-operative Photograph of Mother on table with treating doctor.
4. Pre-Anaesthetic check-up and preparation for surgery.
5. Per operative photograph of the baby with Umbilical Cord & Placenta with surgeon.
6. Detailed OT notes of C-Section along with Anaesthetist notes and names of Specialists and Nurses.
7. Post-operative progress notes of mother and child for seven days by Specialist.
8. Sutured Wound Photograph after completion of C-Section.
9. Photograph of healed scar at the time of discharge
10. Discharge summary with advice for the Mother and Child.
11. The beneficiaries in Govt. Hospitals utilizing the facility of "Talli Bidda Express" need not be paid transport charges.
12. **Ante-natal/ Intra-natal/ Post-natal Blood transfusion, (upto two units) if necessary, shall be done at free of cost as a part of the package. If more than two units were transfused, enhancement can be raised for the additional cost incurred.**

13. **Baby resuscitation & Paediatrician consultation, Warmer charges and Medicines should be provided at free of cost as a part of the package.**
14. **If any complication has occurred directly related to the procedure within 30 days of discharge, shall be treated at free of cost as a part of the package.**
15. **For any complications leading to extended stay, comorbid condition like HIV, HBsAg, Diabetes, High-end additional investigations, High-cost medicines (Anti D) the hospitals may raise request for enhancement of the package by submitting supporting documents.**
16. **The hospitals can raise another Preauth for other Neonatal, Maternal and other complications not relevant to the procedure done.**
 - I. **Delivery/C section with at least one USG and diagnostics including focussed screening for anaemia and gestational diabetes in each of three trimesters:100% of package rates.**
 - II. **Delivery /C section with at least one USG and diagnostics including focussed screening for anaemia and gestational diabetes in 2nd & 3rd trimesters: 95% package rates.**
 - III. **Delivery /C section with at least one USG and diagnostics including focussed screening for anaemia and gestational diabetes in only 3rd trimester: 85% of package rates.**
 - IV. **Delivery /C section with no USG and diagnostics including focussed screening for anaemia and gestational diabetes in any trimester: 80% of package rates.**
 - V. **Other existing Operation guidelines under Dr. NTR Vaidya Seva are also applicable for the above Procedures.**

The hospitals are requested to strictly follow the above guidelines for successful implementation of the "Talli Suraksha" which is a special unique programme of the Government.
