In the G.O.1st read above, orders were issued authorizing the Chief Executive Officer, Aarogyasri Health Care Trust, to implement software and hardware packages required for Aarogyasri-II Programme with M/s. Tata Consultancy Services (TCS) and duly associating representatives from the Health, the Finance and the IT Departments for the purpose.

2. In the G.O.2nd read above, orders were issued permitting the Chief Executive Officer of Aarogyasri Health Care Trust to get the software, hardware, licenses etc. installed for Aarogyasri-II scheme with an estimated cost of Rs.3,91,84,266/- (Rupees three crores, ninety one lakhs eighty four thousand two hundred and sixty six only) inclusive of all taxes payable to M/s. Tata Consultancy Services, subject to achieving the milestones stipulated therein

3. In the G.O. 3rd read above, orders were issued permitting the Chief Executive Officer of the Aarogyasri Health Care Trust to get additional Hardware and Software installed and extend the service agreement for one year from 20-8-2009 to 19-8-2010 at a cost of Rs.4,66,28,500/- (Rupees four crores sixty six lakhs twenty eight thousand and five hundred only) inclusive of taxes.

4. In the G.O. 4th read above, orders were issued permitting the Chief Executive Officer of the Aarogyasri Health Care Trust to renew service maintenance agreement for one year from 20-8-2010 to 19-8-2011 at an estimated cost of Rs.2,91,31,178/- (Rupees two crores ninety one lakhs thirty one thousand one hundred and seventy eight) plus taxes.

5. In the letter 5th read above, the CEO, AHCT has stated that for the year 2011-12, the issue was placed before the Board of Trustees meeting held on 28-12-2011 under the chairmanship of Hon'ble Chief Minister and the Board of Trustees approved the Service Contract with TCS for maintenance of IT portal from 20-8-2011 to 19-8-2012 at a cost of Rs.9.93,62,872/- vide Trust Resolution No.229/2011 and accordingly the contract is entered with TCS for the period from 20-8-2011 to 19-8-2012. During the review meeting by Hon'ble Chief Minister on 31-7-2012 on review of Aarogyasri scheme, the Chief Executive Officer, AHCT explained about the development and maintenance contract of TCS which needs to be renewed for one more year from 20-8-2012 at a cost of Rs.8.69 crores and it is advised to take orders in circulation with justification. And in the meantime, the Chief Executive Officer, AHCT was advised to float the tenders and finalise a vendor for taking up the development contract and maintenance contract so that new vendor will start operations from 20-8-2013.

The CEO, Aarogyasri Health Care Trust, has therefore requested the Govt. for permission to renew service maintenance agreement with TCS for the year 2012-2013 at a cost of Rs. 8,69,40,410/- (Rupees Eight crores sixty nine lakhs forty thousand four hundred and ten only) includes the development and maintenance of

- a) Rajiv Aarogyasri database driven web portal
- b) 104 database driven call centre web portal, and Blood bank web portal
- c) Employees Health Care Fund data base driven web portal.
