ORDER:

In the reference 1<sup>st</sup> read above, Government, have issued orders authorizing the Chief Executive Officer of Aarogyasri Health Care Trust, Hyderabad, to launch the procurement process for sourcing the most competitive insurance company and a third party administrator (TPA) for the management of two distinct sets of procedures respectively in ten districts of Adilabad, Hyderabad, Kurnool, Vizianagaram, Visakhapatnam, Nizamabad, Khammam, Warangal, Guntur and Krishna (Phase-IV & V – 3<sup>rd</sup> Renewal) from 17.07.2011 to 16.07.2012 and also appointed Technical and Finance Committees for ensuring absolute transparency and equal opportunity in the procurement process.

2. In the reference 2<sup>nd</sup> read above, the Chief Executive Officer of Aarogyasri Health Care Trust, Hyderabad, has informed that as per the orders issued in the reference 1<sup>st</sup> read above, the bidding process has been carried out from 11.07.2011 to 13.07.2011 and the Star Health & Allied Insurance Co. Ltd. has quoted the lowest premium of Rs.279/-per family per year plus Service tax.

3. The Chief Executive Officer of Aarogyasri Health Care Trust, Hyderabad, therefore, has requested the Government to approve the Bidding process and authorize him to enter into Agreement with the lowest bidder, viz., Star Health & Allied Insurance Company Limited at a premium of Rs.279/- per family per year plus service tax for implementation of the Scheme for (192) procedures in ten districts for 4<sup>th</sup> year in Phase-IV & Phase-V, thus amounting the total premium for Rs.257,43,84,337/- (Rs.233,39,83,986/- + service tax Rs. 24,04,00,351/-) for 83,65,534 BPL families for one year.

4. He has also requested to release an amount of Rs.128,71,92,169/- being the first installment to pay to the Insurance Company before the commencement of the policy, i.e., before 17.07.2011, since the premium has to be paid in two installments.

5. The Government, after careful examination, hereby approve the proposal of the Chief Executive Officer of Aarogyasri Health Care Trust, Hyderabad and accord him permission to enter into Agreement with the Star Health and Allied Insurance Company Limited at the premium of Rs. 279/- per family plus service tax for (192) procedures in ten districts referred to in para-1 above for 4<sup>th</sup> year of Phase-IV & Phase-V at a total cost of Rs. Rs.257,43,84,337/- (Rupees two hundred and fifty seven crore forty three lakh eighty four thousand three hundred and thirty seven only) (Rs.233,39,83,986/- + service tax Rs. 24,04,00,351/-) benefitting 83,65,534 BPL families, duly following the rules, regulations and guidelines issued by the Government from time to time.

6. The Chief Executive Officer of Aarogyasri Health Care Trust, Hyderabad, shall furnish a proposal to Government for release of necessary budget, to enable to pay the premium amount to the Star Health and Allied Insurance Company Limited.
