ORDER:

Accordingly, Government hereby release an amount of Rs.106.95 Crores (Rupees One Hundred Six Crores and Ninety Five Lakhs Only) from Chief Minister's Relief Funds to the Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad to incur expenditure towards implementing the Aarogyasri Scheme including online payments to CMCO cases and Journalists' Insurance Scheme.


