ORDER :

In the G.O. 2nd read above, orders were issued enunciating the procedure for processing of representations at CM's Camp Office for providing financial assistance from CMRF to persons other than White Ration Card holders for medical treatment of any of the diseases notified under Aarogyasri-I and II Schemes.

2. The process of verification of eligibility of the beneficiary, the permission accorded for treatment, the report of treatment given by referral/network hospital etc. under the above scheme is being done by Arogyasri Health Care Trust (ASHCT) while the online payment in respect of these cases is made by Revenue (CMRF) Department. After a review of the functioning of this scheme, it is felt expedient that both the functions of process and payments in respect of CMCO cases under Aarogyasri shall be dealt with by a single agency for administrative convenience.

3. Therefore, Government after careful examination of the matter, have decided to modify the procedure involved in the process of claim of the network hospitals and the online payments of the sanctioned assistance by Revenue (CMRF) Department to the cases other than white ration card holders as ordered in the G.O.2nd read above.

4. Accordingly, the following Amendment is issued to the G.O.Ms.No.1012, Revenue (CMRF) Department, dated 12.8.2009:

In the said G.O. for Clause (viii) of paragraph 3 the following shall be substituted namely :

“ The Aarogyasri Health Care Trust (ASHCT) shall process the claims of the network hospitals and pay to the hospital concerned

5. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, shall take necessary further action accordingly.
