ORDER :

In the G.O. 3<sup>rd</sup> read above, orders were issued enunciating the procedure for processing the claims of Network Hospitals in respect of accredited Journalists in the State for medical treatment on the lines of Aarogyasri Scheme.

2. The process of verification of eligibility of the beneficiary, the permission accorded for treatment, the report of treatment given by referral/network hospital etc. under the above scheme is being done by Aarogya Sri Health Care Trust (ASHCT) while the online payment in respect of these cases is made by Revenue (CMRF) Department. After a review of the functioning of this scheme, it is felt expedient that both the functions of process and payments in respect of Journalists cases under Aarogyasri scheme shall be dealt with by a single agency for administrative convenience.

3. Therefore, Government, after careful examination of the matter, have decided to modify the process of financial assistance to the accredited journalists (working/retired) and their family members who are covered under the scheme as per eligibility.

4. Accordingly, the following Amendment is issued to the G.O.Ms.No.67, Revenue (CMRF) Department, dated 22.01.2009:

A M E N D M E N T

In the said G.O. for Clause (xii) of paragraph 3 the following shall be substituted namely:

“ The Aarogyasri Health Care Trust (ASHCT) shall process the claims of the network hospitals and pay to the hospital concerned online through electronic payment system for which

the funds shall be released by Revenue (CMRF) Department. The Trust shall maintain a distinct account for these cases and render periodical statements to the Chief Minister's Office / Revenue (CMRF) Dept".

5. The Chief Executive Officer, Aarogyasri Health Care Trust, Hyderabad, shall take necessary action accordingly.
