ORDER:

In the G.O.s 1st & 2nd read above, Government of Andhra Pradesh has enhanced the Financial limit from Rs. 2.00 Lakhs to Rs. 2.50 Lakhs and included (100) procedures to the already existing (938) procedures under Dr. NTR Vaidya Seva Scheme per family per annum for the BPL category.

2. In the letter 3rd read above, the Chief Executive Officer, Dr. NTR Vaidya Seva Trust, AP, Guntur has stated that the Government of India has launched Ayushman Bharath PM-JAY on 23.09.2018 with the financial coverage of Rs. 5.00 Lakhs per family per annum for the BPL families identified as per Socio Economic Caste Census (SECC) 2011 data and the Government of Andhra Pradesh has entered into the MOU with National Health Agency, Government of India for implementing the same in the State.

3. The Chief Executive Officer, Dr. NTR Vaidya Seva Trust has requested the Government for enhancement of Financial limit from Rs. 2.50 lakhs to Rs.5.00 Lakhs per family per annum to be implemented from 01.04.2019 onwards under Dr. NTR Vaidya Seva Scheme for providing Cashless treatment for BPL families.

4. Government, after careful examination of the matter, hereby enhance the financial limit from Rs. 2.50 lakhs to Rs. 5.00 Lakhs per family per annum to all the procedures identified under Dr. NTR Vaidya Seva Scheme in the empanelled Hospitals from 01.04.2019 onwards for providing Cashless Health Care Services to the BPL families.

5. The Chief Executive Officer, Dr. NTR Vaidya Seva Trust, A.P, Guntur shall take further necessary action accordingly.

6. This order issues with the concurrence of Fin (HM & FW.I) Dept., vide U.O.No.FMUOPC(HMF1)/8/2019, dated:15/02/2019.
