01. Dr. NTR Vaidya Seva Trust has floated Tender for identification of Manpower Supply Outsourcing Agency vide Lr.No.Dr.NTRVST/HR/287/2017 Dt. 07.09.2017.
02. As part of the Tender Schedule, pre-bid meeting was held on 14.09.2017 at 1100 Hrs. at Trust Head Office, Chuttugunta, Guntur; and as requested by the participating agencies, corrigendum has already been issued on various issues raised by them.
03. In this regard, it is informed that the values that were given under "Manpower Financial Details List" on A.P e – procurement portal are the proposed salaries to be paid by the Trust, on which the bidder can quote up to 5% towards his commission. However, the Trust has been receiving frequent complaints from the bidders that the system is not allowing them to quote the values duly adding with their proposed commission.
04. Therefore, necessary action has been taken to replace the above said values with maximum 5% commission that can be quoted by the bidder, so that the bidder can quote the same value that appear under the said column or less than that.
05. An example is given hereunder for more clarity:  
Existing proposed salary for Hospitality Manager per month: Rs. 25,000/-. This value has been shown as Rs. 26,250/- which includes maximum commission of 5%.

**Note: A. IN THE ABOVE EXAMPLE, THE BIDDER IS REQUIRED NOT TO QUOTE LESS THAN Rs. 25,000/- AND MORE THAN Rs. 26,250/-.**

**B. THE BIDDER CANNOT QUOTE DIFFERENT RATES OF COMMISSION TO DIFFERENT CATEGORIES. IN OTHER WORDS, UNIFORM RATE OF COMMISSION HAS TO BE QUOTED.**

06. In view of the difficulty experienced by the bidders as said in Para 03 above, the time schedule has been revised as under, to enable the prospecting bidders to make their bid:
