
All the District Coordinators of Dr. NTR Vaidya Seva Trust are aware that Dr. NTR Vaidya Seva Scheme is being implemented by Govt. with the objective of providing quality health care and cashless treatment to the member of the Below Poverty Line Families for a total of 1038 procedures including ‘Maintenance Hemodialysis For Crf (MHD) –M.6.5’ through the Network hospitals from Government and private sector with the financial coverage of Rs.2.50 lakhs per family per annum.

Govt. vide ref. 1<sup>st</sup> cited has communicated the approved minutes of the review meeting on Departments achievements, challenges, future strategy for novel approaches to Institutional partnerships held on 10.08.2016 by Hon’ble Chief Minister, Govt. of A.P. for taking necessary action in the matter. In the minutes, it has been stated among others that Govt. approving the strategy of the Dept. reiterated that putting high investment equipment in PPP mode is the correct strategy which has been adopted by the State.

The Commissioner, A.P. Vaidya Vidhana Parishad, Hyderabad vide ref. 2<sup>nd</sup> cited has informed among others that Govt. in association with National Health Mission is launching New State of the Art Dialysis Centres at the locations of Machilipatnam, Tenali, Rajahmundry, Gudur, Srikalahasti, Tadepalligudem, Narsipatnam, Nandyala, Hindupur, Chirala, Palakonda and Parvathipuram and that the Centres at Machilipatnam, Tenali, Rajahmundry, Gudur and Srikalahasti are already in operation and requested to direct the Vaidya Mithras for referring the Dr. NTR Vaidya Seva Scheme cases from nearby areas to the Art Dialysis Centres for availing cashless and quality medical care

services in the identified procedure of 'Maintenance Hemodialysis For Crf (MHD) – M.6.5'.

All the District Coordinators of Dr. NTR Vaidya Seva Trust are therefore requested to issue instructions to the field staff for referring the Hemodialysis cases/patients from nearby areas to the aforementioned Govt. hospitals for availing cashless and quality medical care services under Dr. NTR Vaidya Seva Scheme.
